

(d) Land and Property - Any beneficial interest in land which is within the area of the council. 'Land' excludes an easement, servitude, interest or right in or over land which does not give me or my partner (alone or jointly with another) a right to occupy or to receive income.

 - (a) the landlord is the council; and
 - (b) the tenant is a body in which I and/or my partner is a partner of or a director of or have a beneficial interest in the securities of.

 - (a) that body (to my knowledge) has a place of business or land in the area of the council; and
 - (b) either-
 - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which I and/or my partner have a beneficial interest exceeds one hundredth of the total issued share capital of that class.
